Two finance-specific career advisers help students to make connections with these alumni and to prepare for applying and interviewing.

SUCCESS STORY

Steven Cirincione, Goldman Sachs

Steven Cirincione went straight from the Gabelli School to the investment banking division of Goldman Sachs, landing one of the analyst slots that were sought after by business students across the country.

Steve's path to his first full-time job was lined with internships, beginning in his sophomore year: UBS Wealth Management, then investment bank Berkery Noyes, then Goldman itself. After graduation, Steve and his team handled Goldman's consumer retail and healthcare clients as they accessed the investment-grade debt capital markets.

A highly involved student who represented the Gabelli School on Fordham's student government for two full years, Steve cited his Investments and Securities Analysis class as great preparation for the technical aspects of analyzing stocks and bonds.
